Dear Totally Engaged Americans,

Thank you very much for your unique card. I will cherish this card forever. I am reciprocating this with an "American Flag" signed by each of the Jan 6<sup>th</sup> patriots detained in D.C. We sing the national Anthem every day at 9pm EST, using this flag and others like it. Our very own patriot artist Garrett makes them for us. Hopefully you cherish this unique piece of American history as much as I cherish the card you guys sent and signed to me.

Please allow me to tell you a little about me and our conditions in jail. My apologies in advance if this letter comes off depressing but It's important we tell our story so hopefully the American public will be aware of our suffering.

I have been languishing in solitary confinement since Jan 28<sup>th</sup>. To describe solitary confinement it's like being trapped in a room not much bigger than an elevator for days, weeks and months at a time. The emotional, mental and physical distress is intense. God has helped me to overcome this trial.

I'm housed in a "cell block" with other Jan 6<sup>th</sup> patriots. We are denied proper nutrition, religious services, clean drinking water, proper hygiene and

medical care. Just tonight our meal consisted of a single paper thin slice of bologna and a single slice of cheese with no bread. Some of us have lost 30-80 lbs in weight and our families would be shocked at the weight loss.

The drinking water comes out brown and we use our white washclothes to help "filter" the water but they quickly turn brown.

We have been denied legal visits with our lawyers and even worst visits with our family. Just a few months ago Marjorie Taylor Green and Matt Gaetz were illegally denied access to us because it's clear the DOJ is trying to hide our plight from the American public and lawmakers.

As if that isn't ghastly enough we fear for our safety from the correction officers. Earlier this year Ryan Samsel a Jan 6<sup>th</sup> patriot and veteran was zip tied and then beaten unconscious by correction officers. He woke up in a pool of his own blood suffering from a detatched retina, broken jaw, fractured orbital, skull ~~fractures~~ fractures, brain swelling and blood clots. The DCDOC has denied this attack ever happened and claim he zip tied his own hands and detatched his own retina which is

Obviously absurd. What was Ryan's offense you may ask. He was trying to organize a 30 minute bible study for patriots. If this sounds like something from "One Flew Out of A Cuckoo's Nest" you wouldn't be far off the mark.

What's even worst (yes it gets worst) is the fact that the narrative the corrupt media, DOJ, FBI and the Biden regime are promulgating is completely fake, phony and false. The truth is we weren't there to start an insurrection we were there to support our lawmakers and encourage them to do the right thing. It wasn't until federal police started beating unarmed peaceful protesters did the altercations begin. What sparked the incident was the murder of Roseanne Boylkin a peaceful unarmed protestor. Officer badge # 5229, 5077, 1213, 5586, 5213, 5622 and 5859 were involved in that cold blooded murder. The Jan 6'ers have this heinous assault on video and the D.O.J. is trying to suppress this video. It's truly heart breaking.

On January 6th 2021 tyranny overtook our capitol and 600 of America's sons and daughters risked everything for the American dream. We sacrificed our lives, liberty, reputations, livelihood,

jobs, and family. I'm going to be frank with you guys, we need your help please don't allow this sacrifice to go in vain. Unfortunately we can't rely on the lying media even the conservative media to tell the truth. We are relying on you American patriots to be the voice of the voiceless.
